Addendum

This addendum has been prepared to demonstrate the changes to the illustrative masterplan in response to KCC Highways comments.

These amendments will help to promote active travel and provide increased connectivity for pedestrians and cyclists.

Access & Movement

The plan below sets the parameters for the access and movement strategy for the proposed development.

In response to the feedback received a shared pedestrian and cycle route has been incorporated into the primary street through the Site. In addition, a cycle connection to Sandwich Road has been provided from the eastern edge of the Site. This is shown on the updated movement parameter plan.

The revised access drawing is shown on the adjacent page. A 2.5m shared cycle and footway is located to the northwestern side of the primary route.

An additional pedestrian and cycle access is provided further south along Sandwich Road.







LaneExisting PRoWProposed footpaths

Street sections

Streets sections B and C have been updated to reflect the provision of a cycleway along the primary route.

The updated street sections are shown here.

Primary Street - North

The cycleway will be incorporated into the northern footway on the primary route. The footpath has been widened to accommodate a shared cycleway.



A shared footway and cycleway will be incorporated on the south western side of the street.


