Thank you for the consultation on the submitted WSI for the archaeological excavation of areas of the above site in advance of areas of Brickearth extraction. I can confirm that this has been written in discussion with myself in advance of submission. It relates specifically to those parts of the development proposals that are covered by the prior quarrying. The area of the site that remains and that wasn't included in the original evaluation scheme, i.e. the former farmyard, should be covered by a watching brief when this area comes forward for construction.

I can therefore recommend that the submission be approved as a suitable scheme to address the archaeological requirements in advance of the quarrying. Full discharge should follow completion of the site works and their reporting as set out in the submission and following the watching brief for remaining areas of the site.
