INFILTRATION BASIN	Power washing surfaces of concrete headwalls of any exposed surfaces to maintain appearance.  If any visible damage to the structure of the headwalls is evident the headwall should be replaced rather than repaired. Minor damage, such as chips can be filled with an epoxy compound such as Mason Mate Polyester Resin.  Clearing of debris/weeds from the grate (if required) to prevent disruption to the flow into the pond.  Headwall handrails require a visual inspection.
