**New Connections at Land off Sandwich Road, Sholden, Deal, Kent, CT14 0AB**

Thank you for choosing us to give you a budget indication for new connections at the above site, and please find our estimate below.

**Work to be carried out**

SGN Connections to install appropriately sized gas infrastructure from the existing 6" SI LP main in Sandwich Road to suitable locations. SGN Connections to carry out all the necessary excavation and reinstatement work. No meter/meter housing work is included.

**Your budget indication is £250,000.00 (exc. VAT)**

Please note that this figure is a budget indication only, it is based upon an hourly load of 250 x 60 kW and an annual quantity of 250 x 20,600 kWh along with any other information you've given us, and doesn't represent an offer to carry out the work.

We won't be able to give you a more accurate quote until a full design study has been carried out, and there's a charge for this. We'll be able to tell you how much the study will be once you ask us for a firm quote.

SGN can confirm that there is sufficient capacity in its Low Pressure network to accommodate this development. This is based upon current network model data which is subject to change. Upon receipt of an application for a firm quote, we will evaluate the actual work required and let you know if any reinforcement is required and if any costs will be applicable.

We're assuming no easements or third party permissions are required to carry out the work.

This budget indication is based on the site boundary being as advised in the information provided by yourselves.

Please note it is SGN's policy to locate gas meters externally wherever possible. Internal meter positions should only be considered as a last resort if no external locations are available. Upon submitting an application for a firm quote, please identify suitable external locations at ground level for the meter boxes, or specify the reasons why internal meter locations are required.

Please note that there is another Gas Transporter (GT), Indigo Pipelines Ltd, within close proximity of your site and therefore you may be able to request an alternative quote from this GT. Should a firm quote be requested, this would be subject to third party consent from the current Gas Transporter close to the site. This consent is required to allow SGN to operate within their area and would be requested upon acceptance of a firm quote.

Please note that this budget indication doesn't allow for any diversion of our existing infrastructure if we find it's necessary.
